



Exports from Ohio helped contribute to the \$2.21 trillion of U.S. goods and services exports in 2016.


Ohio Exports, Jobs, & Foreign Investment

Ohio goods exports in 2016


> **Ohio's Top 5 Export Categories** (Millions of U.S. Dollars)



Exports Support Jobs

Nationally, U.S. jobs supported by exports reached an estimated 11.5 million in 2015, up 1.9 million from 2009.





- Ohio's exports to U.S.
 FTA partners totaled
 \$28.7 billion in 2016.

In 2016, exports to FTA markets accounted for **58%** of Ohio exports
